## MAPPING OF FUNDING OPPORTUNITIES FOR INTERNATIONAL CULTURAL EXCHANGE IN ASIA MOBILITY FUNDING GUIDE

This *Mobility Funding Guide* is a concrete output of the mapping of funding opportunities for international exchange in 19 countries in Asia. It was first released on [culture360.org](http://culture360.org) in September 2012 by the Asia-Europe Foundation (ASEF) with the cooperation of Arts Network Asia (ANA), Korea Arts Management Service (KAMS), Japan Center, Pacific Basin Arts Communication (PARC), and Tokyo Performing Arts Market (TPAM).

Its main objectives are to make available online the existing information on funding that supports the international mobility of artists and cultural operators in Asia and to provide input to funders on how to fill in the existing funding gaps for international cultural exchange in Asia.

The guide follows the existing model of the *Guide to funding opportunities for the international mobility of artists and culture professionals in Europe*<sup>i</sup>, produced by the Foundation Interarts, On the Move and PRACTICS.

In this Asian edition, you can find funding opportunities by country in most artistic and cultural disciplines. The guide lists national resources when available, as well as regional and international sources of funding - be they public or private. Only regular opportunities accessible online are listed. Not included are: funds for which information is only available offline, funds that are not based on open calls, and ad hoc or short-term funding.

For a full overview of the methodology and scope of the research, please refer to the publication's *General Introduction*<sup>ii</sup>.

This guide is an attempt to gather all the resources in one document and is by no means complete. As we aim to update it on a regular basis through further research and input from the field, your feedback is crucial.

### 1. ART ORGANISATIONS' AWARDS

#### 1.1 ArtSociates Indonesia

##### *Bandung Contemporary Art Awards*

**Description:** *Bandung Contemporary Art Awards* is a yearly award organised and funded by Artsociates Indonesia. ArtSociates was established in 2007 with a vision to promote talented artists internationally. ArtSociates focuses on artists that fall into two categories; young prospective artists and good portfolio artists.

**Type of mobility:** Artists- in-residence

**Sectors:** Painting, sculpture, photography, installation, video/new media, Cross-disciplinary arts

##### Eligibility criteria

**Age:** NA

**Nationality:** Indonesia

**Profession:** Artists

**Destination:** Asia and Europe (Germany and Italy in 2011, France in 2012)

**Other priorities:** The artwork for the competition must be a new one

**Grant coverage:** The first prize consists of a cash award of IDR 100,000,000. The three other prizes are residencies overseas (with all related costs covered, including return air-tickets).

### 2. FOREIGN EMBASSIES, FOUNDATIONS AND INSTITUTES

#### 2.1 Embassy of the Kingdom of the Netherlands, Jakarta

##### *Cultural Exchange Funds*

**Description:** Indonesia and the Netherlands share a special cultural relationship, shaped by the historic ties between the two countries. In the framework of the Netherlands' international cultural policy, priority is given to cultural co-operation with Indonesia.

The Dutch embassy in Jakarta has three specific funds—

- The *Culture and Development Fund* for the promotion of cultural identity by giving special attention to the arts sector.
- The *Shared Heritage Fund* for the preservation of cultural heritage by means of training and education or strengthening the cultural infrastructure in Indonesia.
- The *Cultural Co-operation Projects* initiated by Indonesian organisations.

These funds can have an international dimension through projects or training in the Netherlands. It is essential that Indonesian artists (and cultural infrastructure) benefit from the project, and that there is a link with the Netherlands.

**Type of mobility:** Scholarships/postgraduate training courses (trainings in the Netherlands or professional visits linked to the above mentioned objectives); project and production costs

**Sectors:** All fields related to culture and development, as well as to the topics of the cultural cooperation funds; cultural heritage

##### Eligibility criteria

**Nationality:** Indonesian

**Profession:** Culture related organisations/associations

**Destination:** Indonesia and the Netherlands

**Other priorities:** The outcomes can be international but it is important that the projects remain focused

on local support, to the projects with a strong link with the Netherlands. Applications should be submitted along with a business model.

**Grant coverage:** For the *Culture and Development Fund*, the Embassy will fund up to a maximum of 75% of the project costs, the total project costs should not exceed 100,000€ ; funding up to 60% and a smaller fund can be availed under the *Shared Heritage Fund* and the *Culture and Cooperation Fund* respectively.

## 2.2 Marinus Plantema Foundation

**Description:** The goal of the Marinus Plantema Foundation is the promotion of bilateral relationships between the Netherlands and Indonesia through the support of cultural activities as well as through the facilitation of student exchanges. To achieve this goal the Foundation grants subsidies and donations to qualified applicants.

**Type of mobility:** Events participation grants; project and production grants; travel grants

**Sectors:** All

### Eligibility criteria

**Nationality:** Dutch or Indonesian

**Profession:** Artists, arts practitioners

**Destination:** The Netherlands or Indonesia

**Other priorities:** The application should promote relations between the Netherlands and Indonesia in the field of culture, education and science, and (nature) conservation through the facilitation of students' exchanges. The application budget must include all the details of the total cost and specify other sources of funding.

**Grant coverage:** The applicant should contribute at least 10 % of the requested amount. The diversification of funding sources is required.

## 3. ORGANISATIONS WITH A PARTICULAR FOCUS ON ASIA AND/OR SOUTH-EAST ASIA

### 3.1 Asian Cultural Council

**Description:** The Asian Cultural Council (ACC) supports cultural exchange in the fields of visual and performing arts between Asia, the United States and amongst Asian countries. Applications are accepted from individuals and institutions.

The main focus of the ACC grant programme is awarding grants to artists, scholars and arts specialists from Asia for study, research, observation and related activities in the United States of America or in another Asian country.

The ACC considers applications from Asian students pursuing graduate study in universities in the United States. Applications are not accepted for undergraduate programmes and the grant extends

only to living expenses and international airfare. Applicants are encouraged to find other sources of funding for their tuition. Students must apply separately to universities for acceptance while applying to the ACC for funds.

**Type of mobility:** Residencies; scholarships/postgraduate training courses; "go and see" or short-term exploration grants; support for the participation of professionals in transnational networks; "research" grants for scholarships

**Sectors:** Theatre, dance, music, painting, sculpture, photography, design, arts criticism, arts theory, installation, applied arts, video/new media, architecture, cultural heritage, research, cultural management

#### Eligibility criteria

**Nationality:** Bangladesh, Brunei, Cambodia, China, India, Indonesia, Japan, Korea, Laos, Malaysia, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, U.S., and Vietnam

**Profession:** Artists, cultural professionals, scholars, students

**Other:** Individuals are the priority (even if some groups can be supported to a limited level)

**Destination:** United States of America and Asia

**Other priorities:** A limited number of grants may be awarded to institutions for projects involving international exchanges in the arts between Asia, the United States and amongst Asian countries. Grants for projects are usually very modest in size as the ACC's resources are focused on individual fellowships. The calls for applications open in the fall each year for grants starting in the springtime the following year.

**Grant coverage:** NA

### 3.2 Fundação Oriente

**Description:** The Fundação Oriente scholarships programme is one of the essential elements of the Fundação's activities in training. Its main goals are to motivate research in the social sciences and literature related to the Far East; to promote scientific exchanges between Portuguese and Oriental universities and scientific groups; to promote the knowledge of and improvement in knowledge of the languages and cultures of Portugal and the Orient; to stimulate artistic improvement; to encourage training of management staff through scholarships which will allow Oriental students who show great potential but have limited financial means to attend degree courses; to grant access to vocational intermediate training courses for Oriental students with limited financial means.

**Type of mobility:** Scholarships/postgraduate training courses; "research" grants for scholarships

**Sectors:** Painting, photography, cultural heritage, research, architecture, design, art criticism, arts theory

#### Eligibility criteria

**Nationality:** Bangladesh, Brunei, Cambodia, China, India, Indonesia, Japan, Korea, Laos, Malaysia, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, Vietnam

**Profession:** Artists, cultural professionals, scholars

**Destination:** Portugal for Asian nationals

**Other priorities:** Short-term scholarships – applications in June and December; research scholarship – applications in January

**Grant coverage:** Depends on the length of the scholarship (1-3 months) and travel included

### 3.3 Arts Network Asia

**Description:** Arts Network Asia (ANA), set up by an independent group of artists, cultural workers and arts activists from Asia, is an enabling grant body working across borders in multiple disciplines that encourages and supports regional artistic collaboration as well as develops managerial and administrative skills within Asia. Arts Network Asia is motivated by the philosophy of meaningful



collaboration, distinguished by mutual respect, initiated in Asia and carried out together with Asian artists and arts communities. It operates in 11 languages. ANA was created in 1999 by Ong Ken Seng (Artistic director of Theatreworks). ANA is funded through special funds from the Rockefeller Foundation and the Ford Foundation.

**Type of mobility:** Project and production grants

**Sector:** All

**Eligibility criteria**

**Nationality:** Bangladesh, Brunei, Cambodia, China, India, Indonesia, Japan, Korea, Laos, Malaysia, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, Vietnam

**Profession:** Artists, art practitioners, art activists

**Destination:** Asia

**Other priorities:** Deadline for applications is once a year. One of the objectives of the new ANA is to explore the potential of local-regional-global complementation, hence the projects related to inter-generations' local interactions, linking memories, local wisdoms and the future sustainabilities of cultures will be given priority.

**Grant coverage:** Maximum of US\$ 10,000 (travel grants of US\$ 1,000 are also available throughout the year). Applications to be submitted not later than one month before the event.

### 3.4 SEAMEO-SPAFA-Regional Centre for Archaeology and Fine Arts

**Description:** SEAMEO SPAFA, Regional Centre for Archaeology and Fine Arts, is part of the Southeast-Asian Ministers of Education Organization (SEAMEO), an international organization dedicated to promoting co-operation in education, science and culture in Southeast Asia. Among other aims, SEAMEO-SPAFA seeks to further professional competence in the fields of archaeology and fine arts through regional programmes and activities, and through sharing of resources and experiences.

The Centre collaborates with governments, institutions of its member-countries and associate member-countries, international agencies and academic communities, as well as non-governmental organizations and private sector bodies to carry out trainings, seminars, conferences, library and documentation services, staff exchanges etc.

**Type of mobility:** Events participation grants

**Sectors:** Painting, sculpture, photography, architecture, cultural heritage

**Eligibility criteria**

**Nationality:** ASEAN nationals

**Profession:** Experts, practitioners in the field of archaeology, fine arts, conservation and cultural heritage

**Destination:** ASEAN countries or associate countries (rarely)

**Other priorities:** There is no fund as such but regular activities and programmes with possible open calls for applications

**Grant coverage:** Travel grants and accommodation for some projects.

### 3.5 SEASREP Foundation

*Southeast Asian Studies Exchange Programme*

**Description:** The SEASREP Foundation, funded by the Japan Foundation and the Toyota Foundation, is a non-profit and non-stock organisation that aims to promote Southeast Asian studies in Southeast Asia by Southeast Asians through its projects and four grant programmes: language training; visiting professors; the Luisa Mallari Fellowships for M.A., the Ph.D. research in Southeast Asian Studies (run by

the Manila office); and regional collaboration (run by the Tokyo office).

**Type of mobility:** Scholarships/postgraduate training courses; event participation grants

**Sector:** Research

#### **Eligibility criteria**

**Age:** Below 40 years for the Luisa Mallari Fellowship

**Nationality:** ASEAN member countries

**Profession:** For the Luisa Mallari Fellowship for M.A. /Ph.D. research in Southeast Asian Studies: Southeast Asian nationals enrolled in social science or humanities graduate programmes in a Southeast Asian university. For the regional collaboration: any scholar in the humanities or social sciences who is a Southeast Asian national residing in the region, regardless of institutional affiliation.

**Destination:** ASEAN Countries

**Other:** Fellowships aim to foster mutual understanding, and reinforce cross-national cooperation and regional identity of Southeast Asia. Applications are accepted from February to September. The fiscal year runs from 1 April to 31 March. Application forms are available from the Manila Secretariat, the Tokyo Joint Secretariat, the appropriate liaison officers of the eight participating universities, and the Japan Foundation offices in the region.

**Grant coverage:** N. A. Apart from the above mentioned scholarships, there are regular calls for seminars and workshops for which travel grants and accommodation can be covered.

### **3.6 Fukuoka Asian Art Museum**

#### *Curators-in-Residence Programme*

**Description:** The Fukuoka Asian Art Museum (FAAM) is the only museum in the world that systematically collects and exhibits Asian modern and contemporary art. The works in the collection of the museum are not imitations of Western art or repetitions of traditional works. Instead, they seek to overcome the existing framework of art being made by artists living in 'contemporary' Asia.

FAAM invites Asian artists, researchers and curators for an extended period of time in order to present various interactive programmes. The programme aims at enriching local culture, deepening understanding and interest in Asian art among the people of Fukuoka as well as position FAAM as a major centre for exchanging ideas and aesthetics through art.

**Type of mobility:** Residencies

**Sector:** Visual arts

#### **Eligibility criteria**

**Age:** NA

**Nationality:** Bangladesh, Brunei, Cambodia, China, India, Indonesia, Korea, Laos, Malaysia, Maldives, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, Vietnam

**Profession:** Artists, cultural professionals, scholars

**Other:** Researchers who possess a degree or experience and long-term prospects in the study of Asian modern and contemporary art. Curators who possess a degree or experience and long-term prospects in planning exhibitions of Asian modern and contemporary art.

**Destination:** Japan

**Other priorities:** The residency includes research on Asian contemporary art, the organisation of an educational programme and the presentation of the research. Call for the selection of one curator (42 days stay).

**Grant coverage:** Travel, accommodation, allowance, art exchange programme production costs, insurance

### 5.1 The Asia-Europe Foundation (ASEF)

*Creative Encounters: Cultural Partnerships between Asia and Europe*

**Description:** The *Creative Encounters: Cultural Partnerships between Europe and Asia* programme supports multi-lateral projects in various disciplines of contemporary arts including performing arts, visual arts, literary arts, film and new media as well as cross-disciplinary and networking projects. The programme aims to foster engagement across cultures through artistic collaborations, exchanges and dialogues. The objective is to deepen mutual understanding between the cultural communities of the two regions. For the year 2012 Asia-Europe Foundation partners with Arts Network Asia and Trans Europe Halles.

**Type of mobility:** Project and production grants

**Sectors:** All sectors

#### Eligibility criteria

**Age:** NA

**Nationality:** ASEM countries

**Profession:** Arts and cultural organisations, artists and cultural professionals

**Other:** At least two organisations based in two ASEM countries must be involved

**Destination:** ASEM member countries

**Other priorities:** Priority is given to artistic/creative projects and networks which facilitate dialogue, collaborations and exchange between Asia and Europe, including a public outcome.

**Grant coverage:** Maximum of SG\$ 25,000 (matching funding is expected in terms of sponsorship, in kind support etc.)

### 5.3 Ministry of Culture and Tourism, Korea

#### *Cultural Partnership Initiative*

**Type of mobility:** Artists/writers' residencies; scholarships/postgraduate training courses; "go and see" or short-term exploration grants; support for the participation of professionals in transnational networks

**Sectors:** All (from contemporary art to cultural heritage)

#### Eligibility criteria

**Age:** NA

**Nationality:** Africa, Asia, Central/Eastern Europe, Latin America

**Profession:** Cultural fellows

**Destination:** Korea

**Grant coverage:** Depends on the programme but travel costs can be covered.

### 5.4 National Museum of Contemporary Art, Korea

#### *International Fellowship in Cultural Studies of Contemporary Art*

**Profession:** Individuals who work in fields related to contemporary art (museum professionals, curators, art historians, exhibition organizers, conservators, educators, etc.).

**Destination:** Korea

**Grant coverage:** The fellowship includes round-trip airfare, accommodation, monthly living expenses of 900,000 Korean Won, Korean language course fee, and travellers' insurance fees.

## 5.5 European Audiovisual Entrepreneur (EAVE)

### *Ties That Bind (Asia-Europe Producers)*

**Description:** *Ties That Bind – Asia-Europe Producers Workshop* was organised in 2012 in partnership with Friuli Venezia Giulia Audio-visual Fund, EAVE, Udine Far East Film Festival and Busan International Film Festival/Asian Project Market, and supported by the European Union programme MEDIA Mundus. This is the fourth workshop in the series.

The programme is articulated around two workshops. The first workshop takes place at the Udine Far East Festival and second at the Busan International Film Festival. The workshop brings together 10 film producers from Asian and European countries. Each producer is selected together with a feature film project in development and works with leading industry experts from both continents during the two workshops.

**Type of mobility:** Events participation grants (for project development); market development grants

**Sector:** Cinema

#### Eligibility criteria

**Nationality:** Asia (Cambodia, China, Indonesia Japan, Korea, Laos, Malaysia, Mongolia, Myanmar, Philippines, Singapore, Thailand and Vietnam) and Europe

**Profession:** Experienced film professionals with a film in development stage suitable for an international co-production.

**Other:** The producer must have completed at least one film released theatrically in the last three years; the 1st draft of the script for the submitted project must be available in English for the workshop.

**Destination:** Italy (Udine) and Korea (Busan)

**Other priorities:** Projects suggested by Asian applicants should have a potential for co-production with Europe, and projects suggested by European applicants should have a potential for co-production with Asia

**Grant coverage:** The participation at *Ties That Bind* is free of charge. Each participant will be offered accommodation (full board including meals) for the duration of the workshop. In addition, *Ties That Bind* will offer a number of partial scholarships to contribute towards travel costs.

## 5.6 U.S. Department of State's Bureau of Educational and Cultural Affairs and the New England Foundation for the Arts

**Type of mobility:** Event participation grants; touring incentives for groups

**Sectors:** Performing arts, music

#### Eligibility criteria

**Nationality:** Depends on the year but Asian countries often included

**Profession:** Nominations may be submitted by presenters, artists and their representatives, U.S. embassy personnel, regional arts organizations, state arts agencies, and individuals in the U.S. that are knowledgeable about performing arts ensembles in the identified countries.

**Other:** Artists interested in participating may submit a nomination on behalf of their own ensemble. All members of the ensemble must be at least 18 years of age (by June 2014) and a permanent resident of the country in which the ensemble is based. Priority will be given to ensembles that feature individuals who have not previously participated in *Centerstage*.

**Destination:** United States of America.

**Other priorities:** The visiting artists should have an interest in engaging with U.S. communities, including youth, through public and in-school performances, workshops, discussions, artist-to-artist exchanges, and social events.

**Grant coverage:** Travel, accommodation, tours etc.

**Other:** In addition to full-time professional musicians, invitation is also extended to adventurous musicians who double as community organizers, instrument builders, writers, videographers, musicologists, educators, storytellers, dancers, shadow-puppeteers, and more.

**Destination:** United States of America.

**Other priorities:** Interested in collaboration and socially engaged music work

**Grant coverage:** The *OneBeat* programme covers all fellows' travel, transportation, food, and lodging costs.
